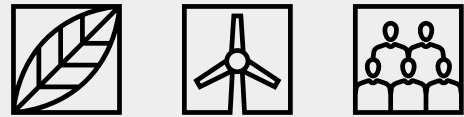

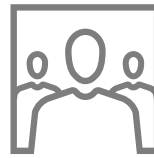

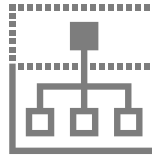

Delivering a complex demerger for a global alternative investment manager

Our client: One of the world's largest alternative investment managers

Our challenge: Implementing a multi-layered restructuring project in a streamlined and cost-efficient way, across multiple territories and disciplines.

Our solution: Our multi-jurisdictional team worked seamlessly across the Legal and M&A Tax disciplines, delivering a cohesive integrated service to the client. Leveraging delivery capability in 7 jurisdictions and a leading Deals technology platform, we managed a suite of over 400 legal documents in a cost-efficient and strategic way, providing 'real time' visibility to the client and other advisers throughout the project. In addition, coordinated weekly fee updates (broken down by workstream, jurisdiction and fee earner) and provided clear cross-territorial fee visibility to the client throughout the project.

The result: Successful delivery of a complex restructuring project which, following worldwide regulatory clearances, closed over 10 consecutive days. Our PwC team worked collaboratively with the client's other advisers, contributing significantly to the overall success of the project.

Case studies: Transformation

Streamlining the global legal department of a major financial institution through managed services

Our client: A global financial institution.

Our challenge: Transforming the delivery of internal legal services across the global bank leveraging a more cost-efficient managed services model.

Our solution: Combining our market leading insights and tech powered solutions, we conducted a detailed internal and external peer review, identifying a £70-80m cost gap in the existing legal function strategic operating model. We proposed a cost saving transformation programme involving legal tech investment and a transformation project team.

The result: Our analysis and recommendations gave our client the business case basis for transformative global savings. We also delivered substantial savings through implementing a Managed Legal Services solution for contract negotiation and remediation, as well as a separate solution to provide multi-jurisdictional corporate legal negotiation services.

Our challenge: The company was undergoing a strategic global transformation. In order to best support the business, their legal and compliance team needed to evolve in line with this transformation, rapidly changing their organisational structure, operational processes, technology and mindset, from existing regional silos towards a global high-performing team.

Our solution: We developed an execution roadmap covering all aspects of their legal operations, and worked alongside the client to implement the recommendations and achieve tangible outcomes. This included working with the business to form a legal services panel, implementation of a new matter & contract management platform, the pilot of an alternative legal sources provider for low value work, a 'voice of client' programme to better understand stakeholder needs and legal project management and continuous improvement training for the client team.

The result: A streamlined, outcomes-driven and flexible legal operations model that is delivering sustainable change for the organisation.

Navigating complex cross-border regulatory hurdles to transform the global shipping industry

Assessing, monitoring and managing compliance on a global scale

Our client: A globally recognised IT/ITeS company.

Our challenge: Conducting a compliance risk assessment across the organisation's key functions (spanning 50+ countries across Europe, the Americas, Asia Pacific, the Middle East and Africa), and helping them to embed a sustainable global compliance model for the organisation moving forward.

Our solution: Leveraging technology and connected expertise, we assisted the client in developing global risk and compliance policies, advised on compliance organisational structure, assisted in developing a new compliance framework (including a law listing and obligation register covering 21 legal compliance areas), helped to implement a periodic compliance update process, and established a global legal helpdesk to address compliance related queries.

The result: a transformed global compliance function that will meet the complex needs of an evolving multinational organisation.

Centralising the global governance function for a global energy company

Our client: A global energy company.

Our challenge: Helping one of the world's largest energy companies rethink and restructure its governance and compliance processes, by creating a centralised model to manage legal entity compliance and governance risks.

Case study: **ESG – Renewables**

A \$30+ billion multi-jurisdictional project powering Australia and Singapore with the world's largest solar farm, battery and undersea cable

Our client: A major renewable energy company

Our challenge: Australia-Asia PowerLink is one of the world's largest renewable energy infrastructure projects. It has complex technical, commercial, legal, tax, procurement and funding considerations.

Our solution: Our innovative approach brought together technical, commercial and risk advisory partners in an Integrated Project Delivery Team. We took a lead role in helping to raise Series A and Series B equity capital, developing the contracting and procurement strategy for AAPowerLink, and advising on multi-jurisdictional legal and tax strategies.

The result: With our ongoing collaboration, AAPowerLink is moving towards the Final Investment Decision and then Financial Close. This is a key step in our client's goal of developing the world's largest solar energy infrastructure network, making it possible to power whole cities with renewable energy.

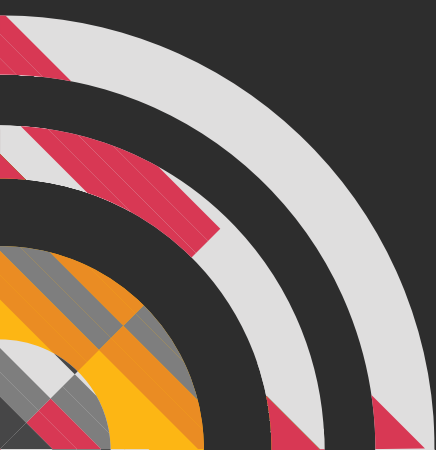

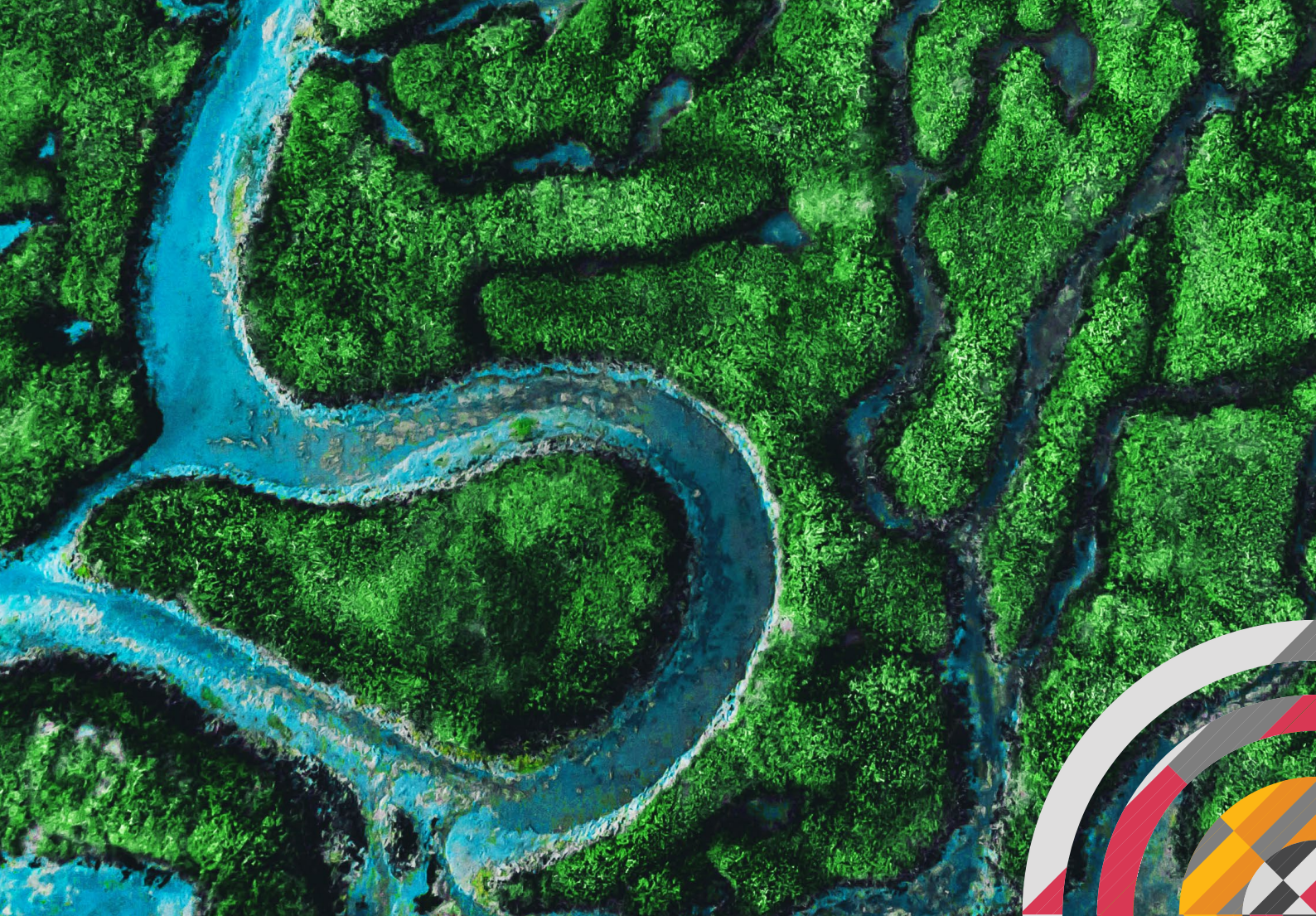
